WHAT IS "MAKING A DREAM?"

Our "Making a Dream" program provides unique opportunities in the hunter/jumper sport to USHJA members who face adversity, such as mental, physical or emotional challenges; resource limitations; or other challenges. Each experience is custom-designed depending upon the specific interests of the "Making A Dream" grant recipient.

WHO MAY NOMINATE?

Any USHJA member, parent, friend or medical professional may submit a nomination on behalf of a USHJA member.

HOW AND WHEN ARE WINNERS CHOSEN?

The full USHJA Foundation Board of Directors reviews nominations quarterly. An individual may be nominated only once per year, and a person may receive the grant only once.
