WHAT IS "MAKING A DREAM?"

Our "Making A Dream" program is philanthropic in nature and extends opportunities to individuals who seek a special experience in the sport of hunters and jumpers, facing unique circumstances. Unique circumstances recipients might face include: physical or other special challenges, or resource limitations. Each experience is custom-designed depending upon the specific interests of the winning recipient who will receive the "Making A Dream" grant. The "Making A Dream" experience will provide up to \$2,500.

WHO MAY NOMINATE?

Any USHJA member, parent, friend or medical professional may submit a nomination.

HOW AND WHEN ARE WINNERS CHOSEN?

The full USHJA Foundation reviews nominations quarterly. An individual may only be nominated once per year and a person may win only once.
